### **SUBJECT DESCRIPTION**

Administrative law is the law that disciplines the operation of the executive branch of government. It is therefore concerned with the organization and decision-making processes of administrative authorities. Administrative law serves two purposes. The first purpose is to ensure that administrative authorities discharge their constitutional functions. From this perspective, administrative law is concerned with the effectiveness and efficiency of administrative action. The second purpose is to prevent abuse of power and to keep administrative authorities under check. From this perspective, administrative law is concerned with the tools that private actors have at their disposal to fight administrative action.

- Identify and understand the interplay between the different tools that legal orders use to ensure legal compliance by administrative authorities (LO 9)

## TEACHING METHODOLOGY
